- 1. Papers to be filed with the Clerk's Office (1 original):
 - Notice of Motion (Click <u>here</u> for sample)
 - Affidavit (include relevant information such as the date of this Court's order of suspension, the reason for your default in registration, a showing of full compliance with the suspension order and Judiciary Law § 468-a, and the residence or other address where communications may be directed to you)
 - Copy of temporary receipt from the Office of Court Administration showing payment of all outstanding registration fees
 - Affidavit of Service showing service on the Attorney Grievance Committees, located at 61 Broadway, New York, NY 10006
 - Check for \$45.00 made payable to "Appellate Division, First Department"
 - Self-addressed stamped envelope
- 2. The motion is returnable only on Mondays.
- 3. Service: For personal service, the motion must be served at least eight (8) days prior to the return date of the motion; for service by mail, five (5) days are added for a total of 13 days. The day of service is not counted. For example: If you personally serve your papers on the Attorney Grievance Committee ("AGC") on May 1st, the earliest date you can make your motion returnable is May 9th if the motion was served by personal delivery, or May 14th if the motion was served by mail (You may contact the AGC if you need short service).
